Essential facts of the Reform were the following:</p> <ul style="list-style-type: none"> - Implementation of the following principles was assured: solidarity, equity, mandatory, money follow the patient. -The Compulsory health insurance budget was separated from the State budget, and a new National Financial State Fund (NFSF) was established. - A centralized system of financing by a single legal entity - National Health Insurance Company (NHIC) and ten territorial branches have been established. - All healthcare organizations have been reorganized into non-for-profit establishments.

			<ul style="list-style-type: none"> - A reimbursement of expenditure on medications for ambulatory care and resort treatment has been taken from State Social Fund and transferred over to NFSF. - NHIC ensured the covering of the ordinary expenditure on out-patient and in-patient healthcare services under the contracts between NHIC and all healthcare legal entities (state and private). - The financing of primary health care services was performed at the basic price / per person. Secondary and tertiary out-patient services financed / specialist consultation. - In-patient healthcare services financed on the basic prices set according to the disease treatment profile group per day and the normative length of stay in the hospital (simple DRG system). <p>Results of the Reform in a year (31.12.1998.):</p> <ul style="list-style-type: none"> -the salaries for medical staff increased to the average of 48%. - all healthcare state organizations have covered their depths. - no strikes. - assured sustainability of the whole healthcare system. - 70 small hospitals have been reorganized to nursing homes and one of the strategic objectives of the Reform was achieved (1 nursing bed per 1000 inhabitants).
